## FREIGHT SERVICE REQUIREMENTS

1. Bill of Lading (BOL) paperwork must be provided, including:
  - A copy for every recipient of your product
    - From (Name of Producer)
    - To (Name of Recipient)
    - To (Address of Recipient)
    - Carrier name (Marty's Local)
    - Pick Up Date
    - Delivery Date
    - Product Name and Description
    - Number of cases and/or number of pallets
  
2. All products must be clearly labeled with:
  - Producer Name
  - Product Name
  - Number of pounds
  
3. Product packaging:
  - Boxes may not exceed a Bushel
  - Boxes may not exceed 50 lbs.
  - Pallets may not exceed the dimensions of 40"x 48"
  - Pallets for pick up may not exceed 5'6" tall
  - Pallets for drop off may not exceed 8' tall
  
4. Delivery days:
  - Deliveries will be made during normally scheduled delivery days
